SUPER BLOC?

MANAMA: An economic super-bloc could soon be forged by the GCC and the European Union.

Bahrain already has the potential to become one of the most attractive markets in the world, said Prime Minister Shaikh Khalifa bin Salman Al Khalifa.

The Free Trade Agreement (FTA) under negotiation between the GCC and EU will make the region stronger, he said yesterday.

The FTA promises huge potential for the two powerful blocs, said Industry and Commerce

Minister Dr Hassan Fakhro. They were speaking as the FTA talks came under the spotlight at the opening yesterday of the Crans Montana Forum Middle East, at the Ritz-Carlton Bahrain Hotel and Spa.

Economic partnership has become a must in the light of the growing globalisation, the Premier said as he attended the event.

A GCC-EU free trade agreement would remarkably increase the volume of trade and enhance commercial and investment co-operation between both sides, he said.

Dr Fakhro said as he opened the forum that the growing market economies of Eastern Europe and the expansion of the EU in general had brought new business opportunities during the last 10 years.

The GCC and Bahrain in particular form the gateway to the Middle East and North Africa region, with a combined population of 380 million and gross domestic product of \$3 trillion, he said.

"It is a large market, too large to be ignored by the EU countries. The combined market of the GCC and the EU is very substantial," said Dr Fakhro.

More than 300 delegates are attending the forum which runs until tomorrow on the theme Central Europe and New Eastern Economies Strategies with the Gulf States.

\$2.7m camel!

ABU DHABI: The Dubai Crown Prince has bought a female camel for a record \$2.72 million (BD1.02m). Shaikh Hamdan bin Mohammed bin Rashed Al Maktoum bought camels worth 16.5m dirhams, including a female camel for 10m dirhams. More than 10,000 camels from across the Gulf are competing in the beauty pageant with a prize money of \$9.5m. The contest is part of a camel festival that aims to celebrate and preserve the region's cultural heritage.

Two die in gas leak

ISLAMABAD: A gas leak killed two people yesterday at a heavy water plant run by Pakistan's Atomic Energy Agency in Punjab province. The leak at the Khushab plant took place during maintenance.

Oil tender planned

DOHA: Bahrain aims to award a tender to double output at its onshore Awali oilfield by the end of the year. The three companies left in the competition for the contract are Exxon Mobil, Occidental and AP Moller-Maersk, said Bapco deputy chief executive Faisal Al Mahroos. Bahrain plans to shut down a 100,000 barrels per day unit at the Bapco oil refinery for planned maintenance for five to six weeks in the fourth quarter. Full report - Page 26

New Iran centrifuges

TEHRAN: Iran has started to install 6,000 new centrifuges at its uranium facility in Natanz, President Mahmoud Ahmadinejad said yesterday. The announcement came as Tehran marked its national day of nuclear technology on the second anniversary of its first production of uranium sufficiently enriched to make atomic fuel.

Man beaten to death

KARACHI: Dozens of Muslim workers at a factory in Pakistan beat to death a Hindu colleague yesterday for alleged blasphemy. Jagdish Kumar, 27, was tortured and killed at the leather factory in Karachi for allegedly making derogatory remarks about Prophet Mohammed, police said.

Halt Iraq pullout urges Petraeus

WASHINGTON: The US general commanding the Iraq war yesterday called for an open-ended suspension of US troop withdrawals in July, saying a rapid withdrawal would jeopardise recent security gains.

General David Petraeus told a Senate hearing that he recommends a 45-day "period of consolidation and

evaluation" once the extra combat forces that President George W Bush ordered to Iraq last year have completed their pullout in July.

Shi'ite cleric Moqtada Al Sadr threatened to lift a seven-month freeze on his Mahdi Army militia if the Iraqi government does not halt attacks on his followers.

Giant turbines make history

BAHRAIN made history yesterday when three giant wind turbines on the Bahrain World Trade Centre (BWTC) became fully operational for the first time.

The 29 metre-diameter blades on the landmark 50-storey building are the world's first to be integrated into a commercial development.

They are expected to provide the equivalent of between 11 and 15 per cent of the power for the BWTC's twin towers and eliminate the need to release 55,000 cubic kilogram calories (kgC) of carbon emissions into the environment every year.

"Incorporating the wind turbines as an alternative source of energy for the buildings will generate 1,100 to 1,300 MWh per year, which is equivalent to lighting 250 homes for more than a year and will create substantial annual savings," said DTZ Bahrain associate director Duajj Al Rumaihi.

"This is a great achievement and speaks of a successful collaboration between several world leaders, including Atkins Architects and Engineers and

"The iconic nature of the building also helps increase the kingdom's stature in the world arena as the Burj Al Arab did for Dubai," he said.

"This increases tourism, commerce and numerous other financial benefits for Bahrain, which therefore makes the turbines an investment that could pay itself off in months rather than years."

Mr Sangill said after their 20-year lifespan was over the turbines could either be removed, refurbished or replaced.

"The costs and safety considerations, which only can be determined later, will influence the decision," he said.

"Preparations have been made for installing a small crane on each bridge which will have sufficient capacity to lift all the main components down bit by bit either for maintenance purpose or for replacement."

Atkins project manager Simha LytheRao said use of established technologies, including type-tested turbines with few modifications ensured that the additional costs incurred by incorporating them into the project was reduced to around 3.5 per cent

of the overall project value.

"This made it not only an environmentally responsible project but also a financially viable venture," he said.
